Portfolio Strategy

Our Cautious to Balanced Risk profile is managed on an outcome basis with an expected long term (10 years plus) average annual rate of return of 5.5%pa, net of all charges. The return target is re-assessed at the start of each year using the portfolio optimisation process. Our long-term equity allocation for this risk profile is 45.0% with a min to max range of 35.0% to 55.0% incorporating targeted long-term risk bands.






